Regarding our pre-trail meeting today.

A brief summary of our meeting was that the Marshes were going to look into removing the overburden on the original retaining wall in order to comply with building regulations.

The Marshes have been told that it would only cost between \$5,000 and \$10,000 to use a different retaining wall construction method using big blocks rather than the reinforced concrete that the existing building permit uses, with a potential saving of \$10,000.

The Marshes agreed to get a firmer quote before a second pre-trail hearing on 30th July.

I agreed to ask for a more detailed quote from the people that supplied the \$19,800 quote that I have been given, to clarify the length of this new boundary retaining wall covered by the quote.
